(vii) Late Filing of Sales Tax Returns:

The Registered Person did not furnish its sales tax returns within due dates for the tax periods July, 2016, August, 2016, September, 2016, November, 2016, December, 2016, January, 2017 and March, 2017. It violated the provisions of section 26(1) of the Sales Tax Act, 1990, read with Rule 18 of the Sales Tax Rules, 2006. Therefore, penalty of Rs.17,000/- is imposed upon it under S.No.1 of the table to section 33 of the Sales Tax Act, 1990.

9. In view of the foregoing, all the charges leveled in the show cause notice are established. Therefore, I order the Registered Person to pay sales tax amounting **Rs.2,140,828,586/-** along with default surcharge (to be calculated till the date of payment of principal amount of sales tax) under section 34(1)(a) of the Sales Tax Act, 1990 and penalty of **Rs.107,041,429/-** under S.No.5 of the table to section 33 ibid. I further impose on the Registered Person penalty of **Rs.17,000/-** under S.No.1 of the table to section 33 ibid for its failure to furnish the sales tax returns within due date.
